

**COSI® FLATBREAD RECIPE CONTEST  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. Internet access is required to participate. Void where prohibited.**

**1. DESCRIPTION OF CONTEST:** The Cosi® Flatbread Recipe Contest (the “**Contest**”) is designed to encourage eligible individuals to use their creativity to create Cosi Flatbread Recipes. A winning entry will be selected in accordance with these Official Rules (“**Rules**”).

**2. ELIGIBILITY:** The Cosi® Flatbread Recipe Contest is brought to you by Cosi, Inc. (the “**Sponsor**”). The Promotion is open only to legal residents of the forty-eight (48) contiguous United States (excludes Alaska & Hawaii) and the District of Columbia. To enter, you (“**you**” or “**Entry**”) must be at least eighteen (18) years old at the time of entry. Employees of Sponsor, franchisees and licensees of Sponsor, and each of their parent and affiliate companies, and suppliers, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee, are not eligible. **4. HOW TO ENTER:** The Contest will be hosted on Instagram (and also advertised on Facebook, TikTok and Twitter). Entrants will create a recipe for Cosi Bake-at-Home Flatbreads and post a picture or video of the final product or recipe to their Instagram account using the hashtag #getcosi.com. Each eligible Entrant submitting an eligible entry will be eligible to win a 6-month subscription of Cosi Flatbread. There is a limit of three (3) entries per Entrant during the entire Contest Period. Neither Instagram, Facebook, TikTok, nor Twitter are sponsors of the Contest, and there is no affiliation between Sponsor and Instagram, Facebook, TikTok or Twitter.

**5. ENTRY REQUIREMENTS:** By submitting an entry in the Contest, you hereby warrant and represent that your entry contains only your original content and conforms to the requirements specified in these Rules. Entries must be in English. Entries must meet the following requirements:

YOUR RECIPE, PHOTO, VIDEO, ENTRY MUST BE ORIGINAL CONTENT CREATED BY YOU AND MUST NOT INCLUDE CONTENT CREATED OR OWNED BY ANY OTHER PERSON OR ENTITY. Sponsor reserves the right to, and may or may not, monitor/screen entries prior to posting them to its Website or Social Media. By entering, you acknowledge that Sponsor has no obligation to use or post any entry you submit. Submission of an entry grants Sponsor and its agents an unlimited, worldwide, perpetual, license and right to publish, use, or publicly perform the entry in any way, in any and all media, without limitation, and without consideration to Entrant. Any waiver of any obligation hereunder by Sponsor does not constitute a general waiver of any obligation to Entrants.

If any winner is not able to accept, or does not accept, the prize for any reason whatsoever, then Sponsor reserves the right to award the prize to another Entrant. The decision will be made by Sponsor based on criteria determined by Sponsor, which may include, without limitation, taste, visual appeal, ease of preparation, ingredients, etc.

**7. PRIZE DETAILS/ODDS:** One (1) winner will be selected by Sponsor and will receive a FREE 6-MONTH SUBSCRIPTION TO COSI FLATBREAD (Original or Multigrain, at the winner's option), including the Flatbread and free shipping, valued at approximately \$150.00. In case of dispute, the authorized subscriber of the email account used to enter the Contest at the actual time of entry will be deemed to be the Entrant and must comply with these Official Rules.
