The WYCC Initiation Fee is non-refundable. The \$100/share Member Stock Fee is due with application and is required for all applicants. Dues and fees may represent special membership program charges. Dues and fees are subject to customary increases at WYCC's discretion. Membership and stock fees are non-transferable and are subject to the club's resignation policies. The term of this membership contract is 12 months from the date of membership approval. The required notice period for termination is 60 days. An early termination penalty fee of \$750 will be applied.

A check for the first month's dues and fees, including initiation fee and Member Stock Fee, must be attached to this application. Should the application not be approved, any check will be returned to the applicant.

PAYMENT OF MEMBERSHIP ACCOUNT

If accepted into membership, I will pay my account in full when due, including any processing fees. A late charge of 18%, or the highest allowable by law, will be assessed for past due accounts. In addition to late fees, penalties may include, but not limited to suspension of club privileges and/or expulsion from the club.
